Your personal information is collected and managed in accordance with the Information Privacy Principles described in the Information Privacy Act 2009 and, if applicable, in accordance with section 426 of the Education (General Provisions) Act 2006. You can access your own personal information by contacting the Queensland State Award Office.

BLUE CARD

Under the *Commission for Children and Young People and Child Guardian Act 2000* people working with children under 18 in certain categories of business or employment must undergo the Working With Children Check. **The Commission for Children and Young People and Child Guardian has determined that the Working With Children Check (blue card system) now applies to employees or volunteers associated with The Duke of Edinburgh's Award and the Bridge Award programs.** Employers and businesses providing regulated child-related services are also required to have a written child and youth risk management strategy in place to protect children and young people from harm.
